Wedding photos will be processed and delivered via an online gallery within 30 days during the wedding season. Engagement, Family, and Lifestyle photos will be processed and delivered via an online gallery within 1-2 weeks.

Yes, you can upon request. I will deliver those photos to you via Flickr within 10-15 days after the wedding during the wedding season.

**HOW MANY HOURS OF COVERAGE ARE WE GOING TO NEED?**
